

# Prolact RTF 28 Human Milk-Based Premature Infant Formula (100 mL) Product Preparation Log Sheet

This log sheet should be completed by the staff who will prepare Prolact RTF 28 premature infant formula (100 mL) for administration and feeding.

**Directions for Preparation and Use**  
 Store at 20° C or colder until ready to use. Do not microwave. Once thawing process begins, administer within 48 hours. Gently swirl bottle to mix. DO NOT SHAKE. Once mixed, keep refrigerated until used. The health of the infant depends on carefully following the directions for preparation and use. To be used under the supervision of a physician.
